h) against "West Bengal University of Health Sciences, Kolkata" under the heading Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Psychiatry)"

MD(Psychiatry)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Medical College, Kolkata on or after May, 2013.

"Master of Surgery(Ophthalmology)"

MS(Ophthalmology)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Nilratan Sircar Medical College, Kolkata on or after May, 2013.

Note to all: 1. The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
