**NOTIFICATION**

S.O..... 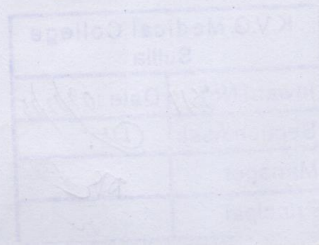


