**NOTIFICATION**

S.O..... In exercise of the powers conferred by sub-section(2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, due to change of nomenclature of the qualification namely:-

In the said Schedule -

a) against "Rajiv Gandhi University of Health Sciences, Bangalore" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine/Master of Surgery(Obstetrics & Gynaecology)"

MD/MS(OBG)

(This shall be a recognised medical qualification when granted by Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka in respect of students being trained at A.J. Institute of Medical Sciences, Mangalore, Karnataka on or after May, 2012.

"Master of Surgery(Ophthalmology)"

MS(Ophthalmology)

(This shall be a recognised medical qualification when granted by Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka in respect of students being trained at K.V.G. Medical College, Sullia, Karnataka on or after May, 2012.

"Master of Surgery(Obstetrics & Gynaecology)"

MS(OBG)

(This shall be a recognised medical qualification when granted by Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka in respect of students being trained at K.V.G. Medical College, Sullia, Karnataka on or after May, 2012.

b) against "Nitte University, Bangalore, Karnataka" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Pathology)"

MD(Pathology)

(This shall be a recognised medical qualification when granted by Nitte University, Bangalore, Karnataka in respect of students being trained at K.S.

Hegde Medical Academy, Mangalore on or after May, 2012.

c) against "Calicut University, Kerala" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Master of Surgery(Orthopaedics)"

MS(Ortho.)

(This shall be a recognised medical qualification when granted by Calicut University, Kerala in respect of students being trained at Govt. Medical College, Thrissur, Kerala on or after June, 2011.

"Doctor of Medicine/Master of Surgery(Obstetrics & Gynaecology)"

MD/MS(OBG)

(This shall be a recognised medical qualification when granted by Calicut University, Kerala in respect of students being trained at Govt. Medical College, Thrissur, Kerala on or after June, 2010.

"Doctor of Medicine(Microbiology)"

MD(Microbiology)

(This shall be a recognised medical qualification when granted by Calicut University, Kerala in respect of students being trained at Govt. Medical College, Thrissur, Kerala on or after June, 2012.

d) against "Vinayaka Mission's University, Salem, Tamilnadu" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Dermatology, Venerology & Leprosy)"

MD(DVL)

(This shall be a recognised medical qualification when granted by Vinayaka Mission's University, Salem, Tamilnadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamilnadu on or after April, 2012.

"Master of Surgery(Obstetrics & Gynaecology)"

MS(OBG)

(This shall be a recognised medical qualification when granted by Vinayaka Mission's University, Salem, Tamilnadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamilnadu on or after April, 2012.

"Doctor of Medicine(Paediatrics)"

MD(Paediatrics)

(This shall be a recognised medical qualification when granted by Vinayaka Mission's University, Salem, Tamilnadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamilnadu on or after April, 2012.

“Master of Surgery(Ophthalmology)”

MS(Ophthalmology)

(This shall be a recognised medical qualification when granted by Vinayaka Mission's University, Salem, Tamilnadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamilnadu on or after April, 2012.

e) against “The Tamil Nadu Dr. MGR Medical University, Chennai” under the heading ‘Recognised Medical Qualification’ [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading ‘Abbreviation for Registration’ [hereinafter referred to as column (3)], the following shall be inserted, namely:-

“Doctor of Medicine(Physiology)”

MD(Physiology)

(This shall be a recognised medical qualification when granted by The Tamil Nadu Dr. MGR Medical University, Chennai in respect of students being trained at Thanjavur Medical College, Thanjavur on or after May, 2011.

f) against “Sri Ramachandra University, Chennai” under the heading ‘Recognised Medical Qualification’ [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading ‘Abbreviation for Registration’ [hereinafter referred to as column (3)], the following shall be inserted, namely:-

“Diploma in Tuberculosis & Chest Diseases”

DTCD

(This shall be a recognised medical qualification when granted by Sri Ramachandra University, Chennai in respect of students being trained at Sri Ramachandra Medical College & Research Institute, Chennai on or after May, 2012.

g) against “West Bengal University of Health Sciences, Kolkata” under the heading ‘Recognised Medical Qualification’ [hereinafter referred to as column (2) ], after the last entry and entry relating thereto under the heading ‘Abbreviation for Registration’ [hereinafter referred to as column (3)], the following shall be inserted, namely:-

“Doctor of Medicine(Pathology)”


MD(Pathology)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Medical College, Kolkata on or after May, 2012.

Note to all: 1. The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.  
2. Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
