In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MS(Otorhinolaryngology) qualification for 02 (01 & 01 to 02) seats in respect of students being trained at K. V. G. Medical College & Hospital, Sullia under Rajiv Gandhi University of Health Sciences, Karnataka**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
